The Iowa Permit Technicians Association (IPTA) is a nonprofit organization established in 2019 by permit technicians and associated professions for the purpose of providing, promoting, and supporting education and networking. We are an organization that seeks to foster professionalism, certification, and recognition of its membership. We are comprised of permit technicians, front counter personnel, plans examiners, building officials, planners, and others across building, planning, and zoning departments throughout the state.

Monthly Zoom meetings have focused on rebuilding the organization post-COVID and center on what we can provide to meet the needs of the membership. In the fall, IPTA hosts our annual in-person meeting and conference, during which time we offer an educational class for those looking to expand their knowledge, for networking opportunities, and for those looking for CEU credit hours.

Each jurisdiction must have one person designated as a Class A member. Additional members are considered Class B members.

MEMBERSHIP CATEGORIES

<u>Class A:</u> The Appointed Designee is the primary active member for a city, county, or state building department that has adopted a building code. These members are allowed to vote at the Annual Meeting, are eligible to chair a standing committee, and may be elected to office.	\$40
<u>Class B:</u> Any additional Building Department personnel other than the Appointed Designee, who are employed by a government jurisdiction that enforces building codes. These members are allowed to vote at the Annual Meeting, are eligible to chair a standing committee, and may be elected to office.	\$10
<u>Associate Members:</u> Representatives from industry and other persons interested in or allied with building construction. Associate Members shall not be allowed to participate in voting at the Annual Meeting, chair a standing committee, or be elected to office.	\$40
<u>Retired Members:</u> Those from any classification who have retired from active service but wish to maintain their association with, and participation in, the affairs of IPTA. Retired Members shall not be allowed to participate in voting at the Annual Meeting, chair a standing committee, or be elected to office.	Free
<u>Honorary Members:</u> Election to Honorary Membership shall be in recognition of exemplary service and outstanding contributions to IPTA. Honorary Members are nominated and elected to this class of membership by the IPTA membership at any Annual Meeting. Honorary Members shall not be allowed to participate in voting at the Annual Meeting, chair a standing committee, or be elected to office.	Free
